#### PRIVACY POLICY

This privacy policy is for this website <a href="https://ssa.co.za">https://ssa.co.za</a> served by Strategic Solution Architects (Pty) Ltd, registration number 1991/002268/07 ("SSA") and governs the privacy of its users who choose to use it.

The policy sets out the different areas where user privacy is concerned and outlines the obligations and requirements of the users, the website and SSA. Furthermore, the way this website processes, stores and protects user data and information will also be detailed within this policy.

- 2.6.3. promptly notify you if we become aware of any unauthorised use, disclosure or processing of your Personal Information;
- 2.6.4. provide you with reasonable evidence of our compliance with our obligations under this privacy policy on reasonable notice and request;
- 2.6.5. upon your request, promptly return or destroy any and all of your Personal Information in our possession or control, save for that which we are legally obliged to retain same;
- 2.6.6. not retain your Personal Information longer than the period for which it was originally needed, unless we are required by law to do so or you consent to us retaining such information for a longer period:
- 2.6.7. do all things reasonably necessary to protect your rights of privacy.

## 3. DISCLOSURE

- 3.1. SSA may disclose information about you to any of its employees, officers, agents, suppliers or subcontractors insofar as reasonably necessary for purposes of fulfilling its services mandate to you.
- 3.2. In addition, SSA may disclose information about you:
- 3.2.1. to the extent that SSA are required to do so by law;
- 3.2.2. in connection with any legal proceedings or prospective legal proceedings;
- 3.2.3. in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk); and
- 3.2.4. to the purchaser (or prospective purchaser) of any business or asset which we are (or are contemplating) selling.
- 3.3. Except as provided in this privacy policy, SSA will not provide your Personal Information to third parties, including but not limited to third party advertisers and third party product and/or service providers. It will be your choice whether you wish to contact them and provide your Personal Information to them.
- 3.4. Occasionally, third parties may provide information processing services to SSA.
